

RUIDOSO DOWNS 2025 QUARTER HORSE TRIPLE CROWN TERMS AND CONDITIONS

The undersigned represents that he/she and all persons for whom he/she is acting agree to be bound by and comply with the New Mexico State Racing Commission (NMRC) Rules of Racing, the Ruidoso Downs' race meeting conditions, and the acts and decisions of the NMRC and All American Ruidoso Downs LLC (AARD) management. Further, that all horses owned in whole or in part by the undersigned are subject to the acts and decisions of the NMRC and the racing officials and agree to be bound by these terms and conditions. All stall assignments, entries in stakes and all other races, are received and accepted subject to compliance with all conditions, rules and regulations of the NMRC and ALL American Ruidoso Downs, LLC (AARD). It shall be the Nominator's responsibility to notify AARD of ownership and address changes and to make timely payments. AARD management reserves the right to establish the appearance and arrival time to Ruidoso Downs enclosure for any horse entered in a Ruidoso Downs Race.

AARD, further reserves the right to conduct drug or soundness testing, either via NMRC or independently, on any nominated horses at any time while at their current domicile and undersigned agrees to provide access to that horses' domicile to collect test samples. Refusal to provide access to eligible horses on demand by NMRC or AARD shall result in a rescission of eligibility and forfeiture of any payments made in connection with any races.

ELIGIBILITY AND NOMINATIONS: The races are open to foals of 2023 which are registered with the American Quarter Horse Association (AQHA). Nominations to races at AARD do not guarantee stall space. If one or more horses are withdrawn before the race, those horses being withdrawn must be specified at time of payment. Nominators must identify horse(s) associated with all payments. Nominations to this race may be refused or rescinded, without liability, at any time prior to the actual running. There will be no refund of prior nomination or sustaining payments in the event nominator discontinues payments on any horse. Nominations and sustaining fees will be accepted after the payment deadline only through the USPS, FedEx or other recognized delivery services postmarked no later than midnight of the payment deadline. Credit card payments will only be accepted if Nominations Secretary is contacted during business hours prior to the payment due date. Any bank returns for invalid payment constitute non-payment. For all nominating and sustaining payments except the trial entry fee, there will be a grace period of 48 hours to establish acceptable postmarks. An Administrative Fee of 15% will be deducted from all payments. In case of dispute, the only satisfactory evidence of payment shall be a bank cleared check, credit card receipt, or mail receipt each bearing a transaction date that adheres to the above policy. All decisions as to valid payment acceptance shall be made by AARD.

An owner may re-establish eligibility of his/her horses by submitting payment equal to twice the unpaid amount due within 30 days following each deadline. Issuance of an "NSF Check" or stopping payment on a check or credit card tendered to cover any fee shall be absolutely prohibited and shall constitute non- payment.

AARD has responsibility to its patrons, horsemen, and equine athletes to reach for the highest possible standards of performance and compliance, and to maintain a safe, fair and impartial racing enterprise. AARD holds itself to those standards of ethical conduct to protect the interests, safety, and welfare of all racing participants to create an environment of fairness and safety for horses, owners, trainers, and customers. In order to promote these goals and as a condition to remain eligible to the futurity and to participate in any of its races AARD reserves the right to administer a polygraph exam to a nominee's owner, trainer, trainer's employees. This polygraph test may be administered at any time, including post-race, and will be done by a licensed examiner. The exam will encompass any information pertaining to possible regulatory violations.

RAINBOW AND ALL AMERICAN OAKS: Eligible foals of 2023 which complete all payments to the 2025 Rainbow and All American Futurities will be eligible to nominate to the 2026 Rainbow and All American Derbies. Those Derbies will offer an additional race restricted to fillies called the "Oaks" to be run under the same conditions as the "open" race. The purses for the Oaks races shall be apportioned from each race purse account based on a pro rata share of fillies to colts/geldings entered for each race. At entry for the time trials, the trainer of record must designate whether a filly will race in the "open" Derby or the fillies-only Oaks race. Time trials will be conducted among each race division. There will be no stakes race conducted for "non-qualifiers" to the Oaks.

AARD reserves the right to amend these terms of participation and competition at its discretion and at any time within the parameters of the rules and regulations of the New Mexico Racing Commission.

FUTURITY AND DERBY PURSES: Purses for the Ruidoso and Rainbow Futurities are capped at \$1 million each, including added money. Purse funds in excess of \$1 million for Ruidoso and Rainbow Futurity finals will be distributed 70% to the 2026 Ruidoso Derby/Rainbow Derby/Oaks and 30% to the 2025 All American Futurity. The purse for the All American Futurity is capped at \$3 Million, including added money. Purse funds in excess of \$3 Million will be distributed in its entirety to the 2026 All American Derby/ All American Oaks.
